#### Overview

A trusted advisor to government officials, boards of directors, and senior management, Lon has extensive experience practicing law in both the public and private sectors. Lon's past experience as Chief Legal Counsel to Governor Charlie Baker and Deputy Chief Legal Counsel to Governor Weld, as well as General Counsel roles at both Fortune 250 retailer BJ's Wholesale Club and a global strategy consulting firm Boston Consulting Group, and as a stint as a former federal prosecutor in the United States Attorney's Office in Boston provide him with a unique perspective on how to approach difficult legal challenges that his clients face.

Lon's areas of practice are:

- **Litigation and Trial work:** Lon served as a federal prosecutor in the United States Attorney's Office in Boston, investigating, trying, and handling the appeal of cases involving complex financial crimes as part of the Economic Crimes Unit. Lon is currently representing several state agencies, in litigation matters, including a claim involving wrongful termination and violation of the Whistleblower Statute.
- **Internal Investigations:** Lon has assisted several state agencies with their responses to high-profile incidents, assisted in developing policies to respond to immediate agency needs, and ensure long-term public safety. He worked closely with leadership to diagnose challenges, propose paths forward, and implement solutions. He also assists a number of private clients in litigation matters.
- **Legal and Policy Issues related Massachusetts State and Local Government:** When the Commonwealth had to deal with the novel legal and high profile policy issues related to COVID-19, the Executive Office of Health and Human Services and the Governor's Office turned to Lon to help support the Massachusetts Coronavirus Command Center and the Governor's Legal Office on various legal and policy issues arising from the COVID-19 pandemic. In addition, Lon leads a team of Anderson & Kreiger attorneys assisting the Police Officers Standards and Training Commission as it starts up its operations. Lon was also part of a team that provided research to support the task force led by Wayne Budd that investigated police reforms in the City of Boston.
- **Outside Counsel for State Agencies:** Lon is currently advising a number of state agencies on matters involving disputes, and regulatory and public law issues.

Most of all, Lon is a "yes lawyer" who finds creative ways to help clients achieve their business goals and get them where they need to go. That path is yes is not always clear at the outset, but using his knowledge and insight gained from his varied legal roles, Lon finds a legal path to accomplish their business goals. Also Lon understands the intense pressures that some general counsel face from boards and business executives and is able to translate legal reasoning into strategic positioning for their organizations.
